Carolyn began the meeting with introductions. Linda Klembara explained her run for public office and her interest in what our community was doing.

The Minutes were read and Anna made the motion to accept. Steve gave the second. There is one correction to last month's Minutes: Ellis Harvey mulched and added the beautiful flowers to the northern Camp Springs sign.

Lonnie gave the Treasurer's Report. We currently have \$1813.87.

Committee Reports:

Brochures: Debbie is working on those with Keith Neltner. Betty will do the historical synopses of each stone house.

Signs: Nancy will get the lights for our signs after landscaping is done. Victor will donate scrubs for the southern sign. Whitey will have the telephone poles removed so that we can landscape that sign. Marc requested we add the URL to the Camp Springs signs.

Stonehouse Trail: Debbie reported that Kroger was unable to help us with finances at this time. Nancy asked about keeping the trail alongside the road where easements wouldn't be required. Chuck explained that for funding, the trail needs to be separate from the road.

Bridle Trials: Anna reported that a GIS map is being done. Nancy announced that two more homeowners have asked to donate easements for the Stonehouse Trail.

Camp Springs Day: We are considering October 21 for this community event. Suggestions for making public aware were made.

Four Mile Creek Clean-Up: September 16, 2006. CSI will meet at the firehouse at 7:00 a.m. to set up for people. There was a good article in the newspaper about CSI being a pilot program for creek adoption in the state. Several people said they would be available to help with the day's events.

Historic Homes: There was a meeting August 25 at Stonebrook Winery. Ten stone house owners were there (18 folk altogether). Nancy reported that she's requesting old photos for an electronic scrapbook.

Nancy also mentioned that she's interested in involving anthropology students in our work.

Carolyn brought up the Preserve America September 28-30 presented by the Kentucky Heritage Commission. Several from our group are interested in attending the meeting which will be held in Covington.

Covered Bridges: Nothing new to report.

Comprehensive Plan: Chuck has not received responses. He was involved in a 4 hour meeting with the Planning Commission. He suggested we need two separate zoning plans in Campbell County (rural and suburban). No new meetings are yet scheduled.

Wine Festival: Nothing new to report.

Alexandria Fair: Debbie reported that we would be putting together the float at Anna's barn on Tuesday evening prior to the parade. John Buckley designed the float and many hands are needed. Al and Brian Messmer have allowed us use of their hay wagon. Reitman Auto Parts are also helping with transporting the tractor to the fairgrounds and back.
