<u>Historic Homes</u>: There will be a meeting August 25 at the Stonehouse Winery. We'd like to have 2-3 stone houses open for tour for Camp Springs Day. Nancy will work on this.

<u>Brochures</u>: Keith Neltner is interested in pursuing this. We will ask Betty to provide paragraphs of history on the existing stone homes. Dennis will do notes for the winery. We need all agri-businesses to write a small paragraph about each of their businesses.
